

Upholstery Warranty – LDI EnviroWoven® powered by Supreen®

We stand behind the quality of EnviroWoven® powered by Supreen®. The following warranty outlines what is covered, what isn't, and how to make a claim if needed. This warranty applies only to the party that purchased EnviroWoven® directly from LDI Solutions, LLC (LDI). It does not apply to other woven textiles or our coated fabrics. We are not obliged to negotiate any portion of a warranty claim with any party other than the original purchaser. The purchasing party is responsible for coordinating all corrective measures, including those not covered by this warranty. LDI will have a minimum of 30 days to resolve any significant quality dispute.

Coverage Guarantee

LDI guarantees that EnviroWoven®, powered by Supreen®, will meet or exceed accepted industry performance standards for up to three years from the date of purchase in 24/7 environments, provided the products are correctly installed and used under normal conditions.

LDI warrants that EnviroWoven® is free from defects in material and workmanship and complies with any written specifications supplied at the time of purchase. We reserve the right to make changes without notice to the design, specifications, and color.

LDI disclaims all other warranties, express or implied, including (but not limited to) warranties of merchantability and fitness for a particular purpose or application. Once EnviroWoven® leaves our facility, its performance depends on proper installation, care, and maintenance.

Examples of Conditions Not Covered

The following are examples of conditions not covered under this warranty:

- Application design that increases material vulnerability (e.g., sharp frame edges, insufficient padding at stress points, or use of welt cord in exposed high-abrasion areas).
 - Staining that cannot be removed.
 - Vandalism or intentional damage.
 - Sagging, puddling, or loss of tailored appearance.
 - Post-treatment by the customer or third party (e.g., stain treatments, flame retardants, laminations, or other chemical applications).
 - Installation, maintenance, or repair that places undue stress on the fabric.
 - Cleaning or disinfecting chemicals.
